3. **Building and Grounds Committee Held** – A joint meeting between the Building and Grounds Committee and representatives of the New Richland City Council was held on Tuesday, January 29 in the Board Room. Those present from the School District were Travis Routh, Neil Schlaak, Dale Carlson, and Dan Stork. Those present from the City of New Richland were Chad Neitzel, Jessie Shaffer, Wayne Billing, and Ryan Nissen. The current lease agreement in place for Legion Field was reviewed. The District shared maintenance-related items and improvements believed to be priorities to be addressed including: maintenance of fields, dugouts, fencing, concrete work, restrooms, bleachers, and garbage management. Agreement was made to move forward with plans to replace the damaged baseball dugout. Also urgent is the District's desire to improve the playing surface conditions for both the north softball field and the baseball field beginning with addressing a regular mowing and trimming schedule. The B & G Committee and representatives from the City will report back to their board of directors on what was discussed.
