- **4.** Board & Administrator for Board Members Monthly Publication January 2018 Reflection I have provided a brief reflection on a few of the articles from the January publication. I hope you have had an opportunity to read and reflect.
  - Emphasize commitment, open processes when facing competition The article offers ideas on what a school board and superintendent can do to make their district "stand out from the pack" in a time of school competition and choice. Ideas include:
    - ✓ Emphasize being a "community school"
    - ✓ Engage the community
    - ✓ Communication effectively
    - ✓ Be champions of public schools and voice of community
  - <u>Allow angry constituents to cool down</u> The article shares suggestions on policy and procedure for having citizens speak at board meetings.
  - <u>Communicate well with district's internal stakeholders</u> The article offers principles for communicating with staff including:
    - ✓ Show appreciation
    - ✓ Demonstrate support
    - ✓ Make use of a recognition program
    - ✓ Be liberal with praise
    - ✓ Ask their opinion, using forums for dialogue
  - <u>Tips for inexperienced school board members</u> The article offers tips for new board members including:
    - ✓ Take it slow . . . listen and observe
    - ✓ Remember the board's only authority comes from its collective action
    - ✓ Let the superintendent manage the staff
  - <u>Learn as a board and superintendent team</u> The article encourages board and superintendent learning together and offers characteristics seen in high-achieving districts including:
    - ✓ The board learns as a team
    - ✓ The board and superintendent take time to learn together as a team
    - ✓ The board and superintendent discuss "what is most important"
    - ✓ The board engages in policy development
- **5.** Facility Planning Update Thank you for the Board's commitment and priority given to facility planning. It is a great deal of work but so important to the future of the school district. Following the

February 15 work session, next steps include finalizing a community task force that will assist the board in examining priority concerns important to the facility plan.

- **6. Community Night Out** The annual Community Night Out Live and Silent Auction sponsored by the NRHEG Parent Teacher Organization is scheduled for March 17, 2018, to be held at Wedgewood Cove in Albert Lea. The Community Night Out event fundraises for the purpose of contributing to the life of the School District in various ways with a primary focus on students. Participation at the event as well as donations are appreciated.
- **7. School Play Update** As a follow-up to the student public comments at the January School Board Meeting, Principal Bunn has provided the following steps that have taken place.
  - A spring play is moving forward.
  - Mr. Bunn and advisor Mrs. Inouye have met multiple times to discuss the play, including funding, as there was not a budget put forward this school year since a play was not being planned.
  - Mr. Bunn has approved various fundraising efforts requested by Mrs. Inouye.
  - Additional challenges being addressed include scheduling of performances and practices due to limited facility space.
- **8. Insurance Committee** The District's Insurance Committee held its first meeting on February 14. The Committee's purpose is *evaluate insurance benefits for effectiveness, desirability, affordability and competitiveness and make recommendations to the Superintendent and Board of Education.* The committee consists of ten staff members representing different employee groups. Specific committee responsibilities include:
  - Examine issues related to insurance plans
  - Examine other school districts' insurance policies
  - Review district insurance experience
  - Assist with review of plan bids
  - Recommend modifications to insurance plans and benefits
  - Assist with educating employees on health insurance issues and receive input
  - Meet a minimum of four times each year

The committee plans to meet on March 7. Representatives from Flexible Benefits Consulting will be in attendance to assist in facilitating the meeting.

**9. School Board Recognition Week** – The Minnesota School Boards Association set this week of February 19-23 as School Board Recognition Week in Minnesota as a time to build awareness and understanding of the vital function an elected board of education plays in our communities and society. We join all public school districts across the state to celebrate School Board Recognition Week to honor our local board members for their commitment to our communities and to our children.

It takes strong schools to build a strong community, and our board members devote countless hours to making sure our schools are helping every child learn at a high level. They make the tough decisions every month and spend many hours studying education issues and regulations in order to provide the kind of accountability our citizens expect.

The key work of school boards is to raise student achievement by:

- Creating a vision for what our communities want the school district to be and for making student achievement the top priority;
- Establishing standards for what students will be expected to learn and be able to do;

- Ensuring progress is measured to be sure the district's goals are achieved and students are learning at expected levels;
- Being accountable for their decisions and actions by continually tracking and reporting results;
- Creating a safe, orderly climate where students can learn and teachers can teach;
- Forming partnerships with others in the community to solve common problems; and
- Focusing attention on the need for continuous improvement by questioning, refining and revising issues related to student achievement.

School board members give citizens a voice in education decision making. Even though we make a special effort to show our appreciation in February, their contribution is a year-round commitment.
