1) Board Bills: 490,453.84

- **2) Donation:** Pour House Bar & Grill/Nielsen donation to the Clay Target Team in the amount of \$75.
- 3) Staff Development Funding Waiver: Per state statute, public schools in Minnesota must reserve 2% of a district's basic revenue for "staff development activities; programs; plans; and experiences, including workshops, conferences, the cost of substitute teachers, teacher's evaluation, other in-service education, and other related costs." However, Minn. Stat. § 122A.61 allows a school district to annually waive the requirement to reserve all or part of their basic revenue if a majority vote of the licensed teachers in the district and a majority vote of the school board agree to a resolution to waive the requirement." The Board will be asked to approve the decision by the NRHEG Teachers' Association to waive the requirement by not reserving a portion of the required 2% in the amount of \$72,000.00 for the 2017-18 school year which represents about 1.2% of the basic revenue.

1) Co-curricular Contracts: Fall coaching contract for Ryan Evans, 8th Grade Football

Resignation: Barb Handahl, Family Service Coordinator, effective date-November 17, 2017. Ms. Handahl has been with the District since January 19, 2010.

3) Special Education Service Agreements:

- a) **Deaf and Hard of Hearing (DHH) with Owatonna Public Schools:** Director of Special Education, Heather Harms, has arranged for our district to contract DHH services with Owatonna Public School. The contract is from July 1, 2017 June 30, 2018 and will be invoiced quarterly. Special Education support from a Teacher for the Deaf and Hard of Hearing for one hour per week or (0.025 FTE). Hourly Rate is \$78.76 (Salary=\$60.02 + Benefits=\$18.74) @ 38 hours + Mileage.
- **Assurance of Compliance with State and Federal Law Prohibiting Discrimination:** The Assurance of Compliance identifies specific state and federal laws pertaining to discrimination and equity protection. As part of the Assurance of Compliance, all districts must verify that there is a copy of each of the identified laws in every building in the district. NRHEG also provides this information on the front page of the District's website.
- 5) <u>Statewide Enrollment Options:</u> We have six (6) students living in our District but choosing to attend a different school not in our district.
